**AND WHEREAS,** under the *Public Libraries Act, R.S.O. 1990*, public libraries in Ontario must be operated under the management and control of a public library board, which has the authority to formulate policies concerning the operations and services of the public library, however, on the contrary, the Council of the Township of McGarry has maintained a closer involvement with the library operations

**AND WHEREAS,** the aforesaid relationship leads to the implication that the municipality is the employer, which has the potential to leave the municipality in a position that may be susceptible to liability especially upon consideration that the board may hypothetically operate autonomously, in accordance with the *Act*, and without municipal oversight

**AND WHEREAS,** the apparent need to restructure and re-establish seems to have resulted in the library board being inactive since spring 2019 despite no official decision being made in that regard by the either the Council of the Township of McGarry or the library board

**AND WHEREAS,** the CEO for the McGarry Public Library may not have been provided with clear direction with respect to policies and procedures in the absence of an active library board

**AND WHEREAS,** the CEO for the McGarry Public Library has recently started advertising for a haircut program

**NOW THEREFORE,** the Council of the Corporation of the Township of McGarry **disapproves of the library's new haircut program**, and reserves the right to approve future programs and service levels at least until an autonomous library board is established.
